§ 1

The Eugeniusz Geppert Academy of Art and Design in Wrocław and The Turiec Gallery in Martin, hereinafter referred to as the Parties to this Agreement, hereby declare their intention to initiate permanent cooperation in the artistic, scholarly, didactic and promotional areas.

§ 2

1. Cooperation between the Parties to this Agreement will be executed in the form of mutually agreed upon activities including, without limitation, the following:
  - a) The joint organization of exhibitions, scholarly conferences, symposia, seminars;
  - b) The execution of artistic and didactic projects in the area of mutual interests;
  - c) Conducting joint scholarly research;
  - d) The exchange of artistic experiences and academic information;
  - e) The sharing of experiences related to education and educational programmes;

- f) The development of contacts (relations, bonds) between students and employees of both institutions.
- g) Joint participation in international projects and programmes;
- h) Joint publications, with the use of data bases of both parties;
- i) The development of other forms of cooperation as agreed upon between the Parties.

2. Within the scope of their cooperation and subject to the principle of using materials acquired by the Parties from each other (logotypes, information and promotional materials) in the manner ensuring their integrity and the protection of the Parties' reputation, the Parties to this Agreement agree to the following:

- a) To have their respective logotypes placed on promotional materials and websites together with a note about their cooperation and jointly executed projects (if applicable);
- b) To have their information and promotional materials displayed in visible places in the partners' offices or other agreed upon locations (if possible);

§ 3

1. The Parties' representatives appointed to maintain regular working contacts between the Parties and to supervise the execution of projects initiated within the scope of their cooperation:

Either Party can terminate this Agreement in writing. Such termination becomes effective one month after the delivery of a relevant notice of termination.
- 2. This Agreement has been drawn up in two copies, of which either Party receives one copy.
- 3. The Parties' entering into this Agreement does not oblige them to incur any financial liabilities unless the Parties have previously agreed otherwise with respect to particular activities.
